Dear friend

I am at present stopping here

have taken several orders I
will go to Fish Haven to
morning morning I think this
is a most delightful place I
like it very much I am stopping
at a Mr. Alread (no name)
but Alread Mr. Nov. I said
that I would tell you all of the
incidents that happened The first
and most interesting took place
at Mrs. Brown's dinner table on
Sunday just before leaving they
were all getting a bout my departure

and the broken hearted girls that
I would leave behind 1894.

Just at the time there was a little
girl who came into the room
and said "I know a good joke
on Mr Bean" I asked her when
she heard it and she said that her
teacher told her it stands to
reason that all would want to
know what it was! My sister
mamma in reply was equally
suctioned! She said that the
teacher said that Mr Bean came
down to see his girl one night
and brought a big watermelon
under each arm and at last
he was almost sick!

I was not sick that night but
some time after I was taken very
ill and they concluded that
was the night and claimed
to have a capital joke on me

I fail to locate the joke if there
is any whether it is on me the
watermelon or the Teacher
I will admit that I brought
them and I was sick (but
not on that night) but I can
not see any joke in that if
so jokes are plenty in the country
where I came from.
